3. Product Description

Intended Use

Monochrome (Ikaros) Mode

The Ikaros system is intended to be used for karyotyping with real-time microscope images from cultured and stained cell specimens in their metaphase. By transferring images of chromosome spreads from the microscope to a computer the labour-intensive manual processing of photographs is eliminated. Karyotypes are assembled by the operator with the support of image processing software. The results are documented in hardcopy and archived for later review.

The system works with brightfield and fluorescent samples with all currently applied banding techniques including G- and Q-banding. All specimens suitable for banding analysis including amniotic fluid, peripheral blood, chorionic villus, bone marrow, and tissue can be used without limitation to specific diseases. Karyotyping is normally applied for the pre- and postnatal diagnosis of birth defects, chromosome abnormalities, genetic diseases, cancer, and for the follow up of cancer treatment.

Colour (Isis) Mode

The colour fluorescence (Isis) mode allows fast and easy acquisition, processing, archiving, and documentation of fluorescent microscopic images.

Legal Classification in the EU



Ikaros carries a self-declared CE mark according to the EU Directive 98/79/EC on in vitro diagnostic medical devices (IVDD).

Neon is integrated in the IVD software packages Ikaros and Metafer but can also be used as a separate software module. Under these conditions Neon is not classified as an IVD software.

Based on the "REGULATION (EU) 2022/112 OF THE EUROPEAN PARLIAMENT AND OF THE COUNCIL of 25 January 2022 amending Regulation (EU) 2017/746 as regards transitional provisions for certain in vitro diagnostic medical devices and the deferred application of conditions for in-house devices" the transition phase of the IVDR (EU 2017/746) was amended.

Devices for which the conformity assessment procedure pursuant to Directive 98/79/EC did not require the involvement of a notified body, for which a declaration of conformity was drawn up prior to 26 May 2022 in accordance with that Directive, and for which the conformity assessment procedure pursuant to this Regulation requires the involvement of a notified body, may be placed on the market or put into service until the following dates: **26 May 2026**, for class C devices. (Note: MetaSystems expects Ikaros to become a class C device under the IVDR).

All Ikaros and Isis systems (including Neon) already installed at customer laboratories by this date, may be used within the scope of the original CE mark. Please inquire if you have any question on the CE status of your system(s).



Ikaros 6.3 has been classified as an IVD product according to the IVDD (98/79/EC).

Legal Classification in the UK

<u>Placing devices on the Great Britain market</u>. According to the *UK MDR 2002*; the *Medical Devices (Amendment etc.) (EU Exit) Regulations 2020*; and the *Decision – Implementation of the Future Regulations* (25.10.2022) the agreed transition period to place CE-marked IVD devices on the Great Britain market was extended until *30 June 2024*. From *1 July 2024*, devices that are placed on the Great Britain market will need to conform with UKCA marking

requirements. MetaSystems' IVD products are registered with the competent authority Medicines & Healthcare products Regulatory Agency (MHRA), and it is planned to achieve UKCA conformity well before the end of the transition period.

<u>Placing devices on the Northern Ireland market</u>. Following the *Northern Ireland Protocol* (Art. 5(4) / Annex 2 (21)), the EU CE-mark for IVD products will remain valid for Northern Ireland.



CE marking is required for the Northern Ireland market. Applying the CE-mark follow the applicable EU and UK legislation.

The UK Responsible Person acts as a regulatory point of contact within the UK and complies with the registration requirement. Please contact Carl Zeiss UK (see front cover for contact details).

Commercial Product Configurations

Ikaros software has the product number: S-0015-001-MS Ikaros 6.3.

Ikaros has been registered in the EU as IVD software (SaMD, software as a medical device) and as an IVD system.

License Protection and Software Feature Control by Hardware Token

MetaSystems software requires the presence of hardware copy protection modules, also known as 'dongles', to be started and executed. Failure to plug in the dongle will result in the software not running. A MetaSystems' dongle does not only work as a security key, but also as a physical license key, which enables particular features in the MetaSystems software.

- Each dongle has an individual serial number.
- Only features enabled by the license key are available in the respective software. All other software features are disabled but can be enabled after purchasing the respective license and reprogramming the dongle.
- The software periodically performs checks for a valid dongle and license key.
- The required **Update Expiry Date** for Ikaros 6.3 is *June 2021* (0621).

In unison, these guidelines emphasize the role and responsibility of experienced cytogenetics in establishing the final diagnosis, for example the European Cytogeneticists Association:

Checking of all cases by a second qualified cytogeneticist is essential. This independent check should involve a single comparison of every set of homologues as a minimum at the required quality for reason the referral reason). The same cells as the primary analyst may be used for the check. A senior supervisor or an experienced cytogeneticist must check the analysis. An independent 'blind' analysis where the checker does not know the first analyst's finding is recommended. (...)

Interphase FISH results must be independently scored by an appropriately trained person. The checker should examine 30-70% of the total of cells used by the primary analyst. If the analyst and checkers' primary scores differ significantly then a third person (if necessary, from another laboratory) must be called in to provide a resolution. This person should normally be informed of the previous scores. For metaphase FISH the same procedures must be used as for checking conventional chromosome analysis. (...) Interpretation of results requires supervision by an appropriately trained physician or cytogeneticist.

We explicitly recommend running our software only on computers with Windows[™] 10/64-bit.

User Access

5. Pre-Installation Requirements

Workspace Requirements

- **Prepare the Workspaces** Ensure that the installation site is clean and empty and that all objects that are not required for setting up the MetaSystems devices are removed.
- **Provide Power Supply** Provide a CEE 7/4 socket (*Schuko*) with 100V-240V, 50-60Hz or a respective adapter for each computer.
- Make Sure There is Enough Space The recommendation for just a computer workstation is a workspace of 90 x 70 cm (w x d). If the workstation is combined with a microscope, the available workspace should not be smaller than 130 x 80 cm (w x d). Please observe also the applicable national regulations for visual data workstations and EN ISO 9241-1.
- Inform Us about Your Existing Microscope(s) If an existing microscope shall be used with Ikaros, please provide some details prior to the installation: (i) the brand and the model of the microscope, (ii) the illumination devices, (iii) the objective lenses, (iv) the camera adapter, and (v) if applicable, the fluorescence filters available.
- IT Infrastructure Requirements You will generate some image and case data with Ikaros. Please make sure that there is enough storage space available on your data server. The table below gives you an estimate on the amount of data to expect:

We recommend estimating your weekly/monthly workload and the requirement for storage space on the server. Please involve your IT department.



- **Data Management** Data is indexed automatically with the help of a software called NeonServer which runs as a Windows service.
 - For all installations, except for a stand-alone computer, NeonServer should be installed on a separate PC with at least 4 cores, 16 GB RAM, and 100 GB disk space. Dedicated server hardware is not required but recommended. The computer network should allow fast data transfer (1 Gb/low latency).

6. Installation

- **Appoint ,Super-Users'** Determine one or two persons among the users who are responsible for the systems and are available as our contact persons. These persons should be allowed to coordinate and communicate the requests and wishes of the users and to make short-term decisions regarding the system configuration.
- **Provide IT Support** Ensure that IT staff are available for the duration of the installation to respond quickly to any issues related to the IT infrastructure.
- Provide Temporary Administrator Account During the installation phase, our employees require temporary administrator access. This access can be deactivated after the installation and is used to carry out the necessary installations and to test the interoperability of the systems.
- Installation and Training by MetaSystems Personnel We offer installation and training of laboratory staff as a service.
 - We are aware that installation and training may interfere with your daily laboratory routine in one way or the other. Therefore, we suggest making appropriate arrangements which allow your personnel attend the training sessions. Together we can draw up a training plan well in advance to address the general and particular training requirements for every operator of the Ikaros software.
- **Provide Suitable Samples** Ideally, we use your own samples to create training cases as close as possible to your routine work. This will also allow to customize parameter within the software to achieve good results.
- **Training Scope Ikaros** In brief, the training covers:
 - Start and end Ikaros / user login.
 - Settings Data folders, paths, security settings, user groups, reporting.
 - **Navigation** create case, case data import.
 - **Cases** View, search, filter, sort, and group cases.
 - Cases Rename, delete to 'trash', and restore from 'trash'
 - Case datasheet Enter data, customize data sheet
 - Case structure Hierarchical levels: case, scans, cells, culture, slide, region; data on each hierarchical level
 - Case history



- **Cells** Cell List, Cell Gallery, and Combined Karyogram.
- Workflows Manual / automatic (triggered/conditional) workflow progression.
- **Reporting** Printing reports, different report types, customizing reports.

- Software Installations Backups MetaSystems software comes with built-in routines to create backups of the current software installation. Backups are stored (a) locally on the computer running Ikaros, (b) on a network resource chosen by the customer, and (c) at MetaSystems. The latter backup copy helps us to look up configuration details, even if a remote support is not feasible.

7. Post-Installation

■ Allow Us to Support You Remotely – For fast and professional online support, we offer a remote support software tool TeamViewer (branded as 'MetaSystemsQS'). Please note, that remote support by MetaSystems requires a signed Remote Support Agreement form, which is available on request (Remote Support Agreement – MSC-Remote Support Agreement EN-2017-03-02-X.PDF).

TeamViewer is a highly secure remote maintenance solution using fully encrypted data channels. In its latest version, it includes encryption based on 2048 RSA private/public key exchange and AES (256-bit) session encryption. This technology is based on the same standards as https/SSL and meets today's standards for security. The key exchange also guarantees full client-to-client data protection. Access from outside requires a session token which is generated on start-up of the QuickSupport module. This token is only valid during one single session; it is not possible to access the device from outside without it. Do not start the remote access module unless asked by a MetaSystems staff member to do so. You can download the tool from the MetaSystems website:

- 1. Scroll down to Support and a click on Online Support Tool; the download will start automatically.
- 2. Double-click the TeamViewerQS.exe to install. Follow the on-screen instructions.
- Make sure that your device(s) is/are protected against malware and viruses Likewise, we support the installation and maintenance of anti-virus software through your IT department. You should also take all necessary measures to protect the device and your network from harmful influences (e.g., by a network firewall). Please note that the above measures are part of on-site network maintenance, and that MetaSystems assumes no responsibility for damage or data loss caused by inadequate protective measure.
- Software Updates Fixing Software Errors Despite our thorough testing regime, certain software errors may remain undetected until after the initial release of a software version. We are committed to fix known software errors. For this purpose, we will release minor software updates, indicated by the third part of the version number (e.g., 6.3.0 -> 6.3.1). Major issues compromising the proper operation of Ikaros must be reported to the Notified Body and to the Authorities having jurisdiction together with a plan for corrective actions. In this instance, you will be informed.
- Pay attention to regular updates of security relevant drivers and software We strongly recommend updating computers regularly and to keep the drivers and operating system (OS) up to date. If we become aware of any OS patches that may compromise the intended operation of our software, we will inform you and recommend corrective actions.
